## **Explanatory Table**

### **Southwest Metro Station Upgrade Works Package 6 Construct Only Delivery Deed**

#### **Contract Number: 00013/11767**

Capitalised terms in this table have the meanings given to them in the Southwest Metro Station Upgrade Works Package 6 Construct Only Delivery Deed (**CODD**), unless the context indicates otherwise.

In preparing this explanatory table, Sydney Metro has:

- (a) identified the reason(s) under the *Government Information (Public Access) Act 2009* (NSW) (**GIPA Act**) for each redaction; and
- (b) weighed each redaction against the following key public interest considerations for disclosure:
  - (i) promoting open discussion of public affairs, enhancing government accountability or contributing to positive and informed debate on issues of public importance;
  - (ii) creating public awareness and understanding on issues of public importance;
  - (iii) enhancing government transparency and accountability;
  - (iv) informing the public about the operations of the agency;
  - (v) ensuring effective oversight of the expenditure of public funds and the best use of public resources; and
  - (vi) ensuring fair commercial competition within the economy.

Sydney Metro notes that Schedule 40 (*Electronic Files*), Exhibit A (*SWTC*), Exhibit B (*Principal's Insurance Policies*), Exhibit C (*Reports*), Exhibit D (*Initial Contract Management Plans*), Exhibit E (*Construction Methodology*), Exhibit F (*Draft Construction Environmental Management Plan*) and Exhibit G (*Information Documents and Materials*) contain a large number of files and are subject to technical size limitations. As such, these documents to the CODD have not been made available on Sydney Metro's contracts register.
